Dear CISM Secretary General,

The CISM Discipline Commission was called upon request of the CISM Secretary General and convened for the hearing panel on 22<sup>nd</sup> of November 2016, concerning the cases of positive doping results occurred during the 63<sup>rd</sup> World Military Pentathlon Championship held in Weiner-Neustadt, Austria.

The CISM Discipline Commission:

**Considered** the Doping Control Forms confirming that urine samples (numbers 3991480 and 3991573) belongs to **Iulia NAUMOVA**, from the Russian Delegation.

**Considered** the Analysis Result Record sent by Doping Control Laboratory Seibersdorf Labor (accredited laboratory by WADA), which states that the sample code 3991480 and 3991573 showed an Adverse Analytical Finding results for **Bromantan**, in both samples “A”, and “B”, classified as “Stimulants (S6)” at the WADA Prohibited List, version 2016.

**Considered** the rights of the military athlete have been respected included second assessment (Sample B) and during the hearing panel the athlete to be present, to be represented or to send statement of defense.

**Considered** the article 2 (item 2.1), the article 4 (item 4.2.2) and the article 10 (item 10.2.2) of the WADA Code.

**Considered** the substances prohibited in competitions, group S6, in the WADA Prohibited List 2016.

The CISM Discipline Commission, after analyses of the records and files available at the CISM General Secretariat, taking into consideration the WADA Code version 2015, WADA Prohibited List version 2016 and the CISM Anti-doping Rules, presents the following conclusion and sanctions:

1. The athlete is considered to have committed an anti-doping rule violation during the above mentioned CISM sport event, in Weiner-Neustadt, Austria.

2. Taking into consideration the article 10.2.1.1 of the WADA Code, the athlete has to comply an ineligibility period of 4 (four) years, starting from the date collection of the first sample collected, 11 August 2016.
3. CISM Sports Commission should cancel all the results of the athlete in the mentioned Military Pentathlon Championship, as well as in any other event under its competence that she participated since the date of suspension mentioned above.
4. Russian Delegation is to arrange the return of her gold medals and Russian team gold medals to the CISM General Secretariat not later than 20 February 2017. After this date, the CISM SG will reallocate the medals amongst the medal winners.

The CISM Discipline Commission decided to communicate the case and the current decisions to the responsible authorities: WADA, Russian Anti-Doping Agency (RUSADA), Russian Delegation to CISM, and the military athlete Iulia NAUMOVA (through Russian Delegation). According CISM Anti-Doping Rules, Art 12.2.1, the athlete can appeal to the present decision to the Court of Arbitration for Sport (CAS).
