Each nation has the opportunity to come with injured athletes, except in wheelchairs and visually impaired, to participate in the maximum 5 km race. Aim of to promote models of best practice that encourage inclusive opportunities and recognition for athletes with a disability equal to those of their non-disabled peers.

Additional requirements must be included in the preliminary agreement and the host country will be considered as an additional requirement to the extent that they can provide. (The host country will also indicate the possibility of providing additional requirements to countries in advance.)

Veteran soldiers wounded or injured while on active duty may be included as part of a nation's mission and participate in CISM Para sport competition/event

#### D. Access to the Location of the Competition.

All participants arriving to Bosnia and Herzegovina will be welcomed at the Sarajevo international airport or the Sarajevo railway or bus station by the Organizing Committee and transported to the Rajlovac barracks. Participants arriving by car can drive directly to "Rajlovac" barracks. Organizer cannot provide transportation from any other points of arrival.

The cost of travel to and from the host country will be the responsibility of the participating country. The transports to sites of competitions (only) are at the charge of the organizers.

#### Note:

. If you plan to use car with military registration numbers and tactical signs, arrangements for immigration have to be made by the official diplomatic channels (Military attaché).

. The cost of travel to go and come back from Bosnia and Herzegovina will be responsibility of the participating country.

. Bosnian Delegation to CISM will ensure the transportation from the place or arrival to place of stay and also the transport during the competition.

#### E. Conditions of Stay.

During their stay in Bosnia and Herzegovina the missions will be the guests of the AF BiH from 24th May to 27 May 2024. Full board and lodging are at the expense of the organizer. Accommodation will be provided at Military barracks "Rajlovac" in Sarajevo.

Organizer can not host earlier arrivals or late departures. Special requests, like additional drinks or and hotel accommodation (the organizer must be informed during the registration), have to be paid by the delegation itself.

*Extra expenses including: telephone, laundry and drinks must be paid by the consumers.* 

Additional personnel will not be accepted without official written permission of the organizers. *First aid for the participants will be provided by the organizer.* 





## F. Regulations of the Championship.

2nd CISM World Military Half Marathon Championship will be realized in the streets of Sarajevo city and governed by CISM regulations. The following individual and team competitions will be organized:

- ➤ Half marathon (men)
- Half marathon (women)

The competitions will follow CISM (edition 2022) and IAAF regulations for track and field with half marathon. CISM Regulations (Edition July 2023).

The racing distance for the half marathon is km 21.0975.

All participants in the competitions must be entered in the list of accredited competitors, and their entries must be confirmed at latest during the preliminary technical meeting. The race is integrated into the course of the Ilidza Run Alley – We Run



#### 1. Organization

The Organizing Committee will be responsible for the competitions of the 2nd CISM World Military Half Marathon Championship. The opening and closing ceremony will be organized according to CISM Procedure Manual, Article 3.26, Ceremonies and Protocol.

#### 1.1 Venues and times

a. The Organizing Committee will determine the venues and times of the competitions and the teams will be notified accordingly.

b. The Organizing Committee is authorized to change the venues and times of the competitions. These decisions will be final.

#### 1.2 Equipment

The Participating Missions shall undertake to comply with the CISM Equipment Regulations in force. Participating Missions are not allowed to display political, religious, commercial or personal messages in any language or form on their playing or team kits, equipment, or body during the time spent in the halls or any other areas where accreditation is required to gain access.

#### **1.3 Disciplinary matters**

- a. Disciplinary incidents will be dealt with in compliance with CISM Policy Manual 2008, Article 1.11, Sanctions.
- b. The Participating Missions and their athletes agree to comply with the CISM's statutes and regulations; WADA's doping regulations, the equipment regulations, and the commercial regulations. Likewise, agree to comply with all further CISM guidelines, circulars, directives and decisions that apply to the 2th WMC-Half marathon,

c. The players agree notably to:

- behave accordingly their situation as militaries
- refrain from doping as defined by the WADA Doping Control Regulations

#### 1.4 System of competition

Competitions of 2nd CISM World Military Half Marathon Championship will be realized as follows: Half maraton will be realized in the streets of Sarajevo city and governed by CISM regulations. The winners will receive the medal and the military personnel will be ranked in individual and team competition.

The organizer of the 2nd CISM World Military Half Marathon Championship event will provide medals and cups for top three finishers and top three mixed teams (3 men and 3 women). The team time score will be calculated from the total time scores of the finishers from one team.

#### 1.5 Referees

The Organizing Committee will select a Referees' Committee, which in turn will appoint the referees of the competition.

#### 1.6 General

- a. These regulations are but one part of the complete, and the 2nd CISM World Military Half Marathon Championship must be read along with the instructions found in "Basic Rules and Regulations and Disciplinary Procedures".
- b. In the event of a discrepancy between the Regulations written here and those appearing in the "Basic Rules and Regulations", the regulations written here will apply and be binding.

## G. Anti-doping.

Anti-Doping tests will be conducted in accordance with the CISM Regulations – Chapter IX, CISM Anti-Doping Rules, the concerned CISM Sports Regulations, the concerned International Federation Rules, and all WADA rules, mainly the World Anti-Doping Code, and the International Standard for Testing.

The number and type of tests, as well the athletes to be tested shall be determined by the CISM Anti-Doping commission. These procedures will follow the concerned CISM Test Distribution Plain (TDP). In case an athlete has a Therapeutic Use Exemption (TUE), the chief of delegation should send this TUE to the CISM GS until 30 days before the opening ceremony. This TUE will be submitted to the TUE commission to analysis and further approval.

## H. Uniforms.

## I. Medical Care

An adequate medical dispositif and first-aid cover will be provided.

**IMPORTANT**: Since Bosnia and Herzegovina has no military hospitals, we will make use of private medical facilities if the need arises. These services arenot free, and the delegations need to have an insurance which would cover the entire cost of a treatment. All costs have to be payed by the participating nation.

## J. Customs and Visa procedures.

For information on passports and visas for entry into Bosnia and Herzegovina, please contact the Bosnian Embassy in your country.

In order to avoid problems with deadlines for granting Visas adopted by different countries and embassies, we recommend that participants contact the Bosnian Embassy in your own country and schedule an appointment soon after sending the Preliminary Agreement

## K. Weather Conditions.

The average temperatures in Bosnia and Herzegovina at this time are between is 20 to 25 degrees Celsius (during the day).

# FINAL ENTRY - COMMITMENT BY THE CHIEF OF MISSION

NATION:

The undersigned, Chief of Mission declare that he has read the Article 3.28. of the CISM Policy Manual and moreover understood the following prescriptions:

#### Article 1.10. RIGHTS OF MEMBER NATIONS

A. Active member nations have the right to:

- 2. Be invited top all CISM championships.
- B. Inactive member nations have the same rights as active member nations except that:

2. They do not participate in any CISM event until they have met their financial obligations (principle "No Pay – No Play"). If they want to take part in CISM competitions, the membership fee must be paid before the deadline set to return the final entry for the respective competition.

#### Article 7.23. PARTICIPATION - MILITARY STATUS

A. Only military personnel on active duty in Armed Forces may take part in competitions organized by CISM except for Parasport (see below art. 7.23. C.).

B. No one may be recalled to active duty in the Armed Forces for the purpose of participating in a CISM competition. In the case of an intermittent military service, the athletes regularly recalled may not take part in CISM competitions, under any circumstances, if more than 18 months have elapsed between this recall and the end of their last call to arms except for Parasport (see below art. 7.23. C.).

C. Veteran soldiers wounded or injured while on active duty may be included as part of a nation's mission and participate in CISM Parasport competition/event.

D Exceptions to the above may be authorized by the General Assembly, upon recommendation of the Board of Directors. E. All military participants in a CISM event shall be in possession of proper documentation which signifies active military service of the member nation he represents. The documentation can be: 1. a valid military identity card for those athletes who are authorized to present their military identity cards abroad, 2. a form of verification (in English and/or French) of military status accompanied by a passport, 3. For the Veteran para-athletes, the Chief of Delegation concerned must certify in writing that the veteran soldier was wounded or injured on active duty.

F. By signing the final entry, the Chief of Delegation confirms the military status of the participating ath-

letes. If there are last minute changes in the participation of the athletes, the verification file may be signed by the Chief of Mission, but shall be confirmed by the Chief of Delegation by official letter.

G. If one of these documents is not available, participation is refused.

#### Article 7.24. COMPOSITION OF A MISSION

D. Delegations are required to strictly respect the standard composition of a participating mission. No other additional member may be included in the mission without special authorization from the organiz-

ing nation. In all cases where the composition is not respected, missions shall pay the extra accommodation costs.

#### Article 7.26. PARTICIPATION OF AN INACTIVE MEMBER NATION

Athletes or teams of an inactive member nation may not participate in any CISM event (art 1.10 of the Regulations).
