

- Parachuting Regulations edition 2017 will be published at CISM website valid from 01 Jan 2017
- changes to 2016 edition:

A) Substantial change:

Virtual Style limit for team overall raised -> 15sec

B) General:

- Small housekeeping and correction of typos (e.g. 3.3.1.G: the correct role is Chief of Mission)




